—Summary-of— Major Board Actions

PRESIDENT'S REPORT

Well, another new year is upon us, and with it comes an opportunity to sweep out the old and try something new. Here are a few of the changes your Board has implemented:

Change #1 - The last couple years we've had difficulty attracting members to our June luncheons; and so, this year we've eliminated the June luncheon altogether. 

When asked what he did in his leisure time -- golf? bowling? hiking? - he responded, "Fundraising"! He agreed that was somewhat "unusual" and proceeded to explain his interest in helping build a new church in Ohio Township. As a deacon in the church, he led the first stage of the campaign to raise \$1 M! His fundraising experience dates back to 1986 when he was Capital Campaign Counsel for the U. S. Naval Academy in Annapolis and successfully directed the campaign to raise \$28 million to build Alumni Hall.

Prior to that, Mr. Johnson earned a B.S. in Business Administration at Duquesne University, and subsequently, an M.S. in Organizational Development at Robert Morris College. That education paid off in many ways! As May 15, ready to share his expertise Administrative Services Director for on pension plans and financial Allegheny County, he was responsible for overseeing purchasing, elections,

property assessments, services, and facilities management which included a \$25 million budget. Additionally, he was V. ANNUAL FINANCIAL REPORT FOR FISCAL/CALENDER YEAR 2012

on January 1, 2012 in a strong financial position with total assets of \$45,203 and ended the year on December 31, 2012 in an even stronger position with total assets of \$52,691, an increase of \$7,488.

The bulk of the organization's assets are now held in an variable interest rate money market account. At the beginning of the year, money was invested in both certificates of deposit and a money market account and had a total value of \$39,021. As of December 31, 2012 the money market account had a total value of \$40,819 an increase of \$1,738. This included deposits of \$1,580 and total interest of \$218, roughly a 0.56% interest

Total checking account deposits and credits for the year were \$30,086 and total debits and expenses were \$26,537, for a difference of \$3,549.

Our largest source of income, membership dues, was \$21,745. Other

ACRA began the fiscal/calendar year income sources were luncheon fees subsidies, speaker fees, door prizes for 2013 memberships. A more accurate figure for 2012 membership dues is \$16,500 (1100 members x \$15).
