Our speaker was Edd Hale, who has previously addressed the association, with his Great Bank Robbery of Castle Shannon presentation. This meeting Edd, a retired middle school teacher from Keystone Oaks, did a highly informative presentation on the US Brig Niagara docked in Erie. Not only did Edd present the history but included his own firsthand experiences as a volunteer crew member. The brig was very instrumental in winning the Battle of Lake Erie for control of the Great Lakes in the war of 1812. The

famous quote "We have met the enemy, and they are ours" originated from that battle. The ship was sunk to preserve it after the war.

The Niagara is now licensed by the Coast Guard with all the modern equipment. It takes 15-18 professional sailors and 20-25 volunteers to operate the ship whereas in 1813 it took 155 crew.

The US Niagara participates in Tall Ship tours and will be in the upcoming festival in August 25-28. Check <a href="https://www.sailnl.org">www.sailnl.org</a> for the sailing schedule.
