Bob Muessner, chair of the Election Committee, 6 people running for 5 slots, acknowledge the vote counters. List of votes Eric and 2 write-ins were Walt – Carol Update on renewal of investment firm contract for another 5 years. New retirement software is being developed for retirees to access their accounts. Retirements are up 9-10% this year. Life insurance policy with Standard is in effect until 2026.

2023 phased into the next 5 years enrollment age disability end stage renal Part B premium is being reduced 170-165 2021 the Part B premium was 148 up to 170 per year. Increase due to inflation and a new drug breakthrough, from BioGen adyouhelp for dementia. Had to be administered under doctor's supervision. Fast-tracked approval through FDA. 2023 \$97,000. Cutoff for base rate or income adjusted rate.

Six to 7 years for Inflation Reduction Act to reach full fruition 2023 vaccines will have no cost-share. Determined on an unual basis Flu, shingles, covid, no cost. Capping insulin cost at \$35 per month. Manuacturer's price increases will be limited to COLI to Medicare/SSA.

2025 cap of \$2000 on what will be paid for Rx by you. Part D plans Many meds are being shifted from doctor administration to self-administered delivery. Medicare is purposely incuraging this shift from Part B to Part D. Some folks still can't pay the catastrophic 5%. Insurance companies are increasing costs for what will happen in 2025. Max out now to avoid the down the road limitations.

2026 CMMS can negotiate with drug makers prices. For a limited number of drugs.
